

## Privacy Policy

**World Youth Social Organization (WYSO) Trust is committed to protecting the privacy and security of your personal data. Your privacy is important to us.**

WYSO is committed to the ethical collection, retention and use of information that you provide to us about yourself ("Personal Information") on this site [www.wyso.in](http://www.wyso.in) ("Site")

Your Personal Information may comprise the following:

- your name
- your email and mailing address
- your telephone number
- your payment processing details
- limited personal details
- Any other data as WYSO may require

The following Privacy Policy sets forth our understanding with you on the collection, use and protection of your Personal Information. Please read the entire Privacy Policy.

YOUR USE OF THE WEBSITE CONSTITUTES YOUR CONSENT TO THE ALL THE TERMS AND CONDITIONS CONTAINED IN THIS PRIVACY POLICY (AS AMENDED FROM TIME TO TIME) AND YOU SHALL BE BOUND BY THE SAME.

### 1- Site Browsing

1- You browse the Site anonymously. We do not require you to identify yourself or reveal any Personal Information while browsing through the Site. However, you may not be able to access certain sections of the Site or interact with us without supplying us with Personal Information. For instance, you would not be able to transact at the Site or make any donations at the Site, without providing the Site with Personal Information.

2- While you are browsing through the Site, the Site's operating system may automatically record some general information ("General Information") about your visit such as:

- the date and time you visit the Site, along with the address of the previous website you were visiting
- if you linked to us from another website
- the type of browser you are using (such as Internet Explorer version 'X') which 'hit' it is on the Site

3- The General Information is not Personal Information. WYSO tracking system does not record personal information about individuals or link this information to any Personal Information collected from you.

4- The General Information is used by WYSO for statistical analysis, for tracking overall traffic patterns on the Site and to gauge the public interest in WYSO and the Site. Such General Information may be shared by WYSO with any person, at WYSO's discretion.

## **2- USAGE OF PERSONAL INFORMATION :**

### **Personal Information provided by Site users are used for**

- 1- Providing Site users with personalized services and improving user/visitor experience;
- 2- Designing, providing and enabling Foundation activities, events and campaigns;
- 3- Operating the Site and understanding its use, for statistical purposes (number of site visits, average time visitors spend at the site, etc.) and security purposes;
- 4- Managing and processing inquiries, registrations, donations and others interactions with Site users;
- 5- Sending Site users the information requested by them or consented to be received by them;
- 6- Process, manage, complete and account for transactions;
- 7- Sending related information, including confirmations, invoices, technical notices, updates, newsletters, security alerts;
- 8- Maintain records for promotional activities and/or submissions made by users;
- 9- Comply with legal obligations of the Foundation.
- 10- WYSO endeavours to use up-to-date security measures to protect your Personal Information.
- 11- WYSO however does not make any express or implied warranty with respect to the security measures that it may employ from time to time for the protection of the Personal Information.

## **3- SHARING OF PERSONAL INFORMATION:**

Personal Information may be shared internally in order to complete your donations or purchasing transactions, to contact you about our on-going work, discuss employment opportunities, for audits and record-keeping, for fulfilling reporting requirements as required by law, to track visitor trends and behaviour, evaluating Site operation, improve user experience, facilitate provision of User-requested information, research in the course of our work and/or to discuss ways that you can further support our efforts/initiatives. Your Personal Information may also be used to provide you access to restricted/personal sections of our Site.

The Foundation may share, rent or exchange donor names and postal address with third parties, and as permitted by law.

Foundation shall not share your Personal Information with third parties without your prior written consent other than:

- 1- With third parties who work on our behalf provided such third parties adhere to the data protection principles set out in the Information Technology Act, 2000 (21 of 2000) and other applicable legislation, or enter a written agreement with the Foundation requiring that the third party provide at least same level of privacy protection as is required by such principles;

- 2- To comply with laws, respond to lawful requests and legal process or as part of the mandatory legal disclosures;
- 3- With Government agencies mandated under the law to obtain information including sensitive personal data or information for the purpose of verification of identity, or for prevention, detection, investigation including cyber incidents, prosecution, and punishment of offences.
- 4- To protect the rights and property of the Foundation, our agents, customers and others including to enforce our agreements, policies and Terms of Use;
- 5- In an emergency, including to protect the personal safety of any person; and
- 6- For the purpose of a business deal, (or negotiation of a business deal) involving the sale or transfer of all or a part of our business or assets (business deals may include, for example, any merger, financing, acquisition, divestiture or bankruptcy transaction or proceeding)

#### **4- CHILDREN:**

Except in accordance with the legal purposes, provisions and reporting, WYSO does not knowingly collect or solicit personal information from anyone under the age of 18 or knowingly allow such persons to provide us with their Personal Information without parental or guardian consent. If it is discovered that the Personal Information from anyone under the age of 18 has been collected without the consent of a parent or guardian, we will destroy that information as expeditiously as possible.
